This will be an opportunity to engage with your fellow special education administrators to address the current issues in meeting the needs of students with disabilities. We will hear from Dr. Kim Buxenbaum, the Director of the Office of Special Education NJDOE officials about: Due Process, Assessment, Disproportionality, and other new and ongoing important initiatives issues at the state level. You will also hear from experienced directors with a focus this year on restorative and supportive practices within the school to increase effectiveness of instruction while building resiliency. These special education administrators will discuss how they have implemented restorative justice practices, eclectic approaches for therapeutic supports, and the use of the consultative model to support students. David Nash, the Director of LEGAL ONE, will provide valuable information on current legal issues with a focus on those related to Mental Health needs and concerns in the schools. This will be a great opportunity to have the chance to communicate, learn, and share with your colleagues from around the state and interact with state officials.
